



Privacy Policy

Introduction

In strict abidance by the **EU e-Privacy Directive, the Data Protection Act 1998** and other national and international applicable legislation, **LegendaryEA (LEA)** is committed to the pursuance of the policy according to which private information and other related data provided by users of the website legendaryea.com, as well as by subscribers to the products and/or services therein advertised shall remain confidential.

This Policy may be subject to modifications that aim at accounting for possible changes to LEA's operations and practices in response to new business environments, legislation or technology; as well as to the introduction of new products and/or services. It is the user/subscriber's duty to ensure conformity to such changes, as information held will be governed by LEA's most current Policy.

For the purposes of this **Privacy Policy**, **"we", "our" and "us" refers to LegendaryEA (LEA)** and any reference to "you" or "your" means you, the user/subscriber.

About the Information we may Collect

In **Legendary EA**, we maintain our clients trust and confidence is a high priority. We would like to explain what information we will collect from you and the steps we take to safeguard your privacy. It is important that you notice that by registering to any products/services advertised on this website or by providing us with any information, you consent to its collection, use and transfer under the terms of this policy.

We shall only collect information from you that we regard are necessary for providing you an optimal browsing experience as well as for enhancing a premium provision of the products/services to which you register, including but not limited to data requested in forms related to website registration, products/services subscription, posting of material, **problem reports, usage of our “contact us” and “live chat” facilities, and surveys we use for quality improvement.**

In the event you **register and use our “money management” services**, we shall also collect information such as the size of your investment (*i.e., how much you deposit on your trading account*), the amount you allocate in the respective matrix account (*i.e., any sort of account whereby **Legendary EA** can indirectly manage funds from several investors such as **MAMM, PAMM**, or any other selected by **Legendary EA***), the broker you chose, all trading records of the used matrix account, money withdrawals you request, new deposits you perform, etc.

If you subscribe to any other service advertised on this website or on any other also administrated by **LEA**, and agree to use our tracking link under which you register to one of our recommended brokers, we shall collect information related to the size of your investment, all your trading records, possible withdrawals and/or new deposits, etc.

No personal information will be retrieved from our servers when you browse the public (*pre-login*) areas of our website(s). Although we may use website-related information to improve

the content and services advertised on our website(s), including but not limited to traffic data (*i.e., how many people visit our websites, the pages they visit, how long they stay, the domain name of the site from where visitors connect, etc.*), location data (*i.e., IP addresses*), weblogs and other communication data, whether this is required for our own billing purposes or otherwise. Such data is reported on an aggregate, anonymous basis with no personal information associated to it.

Information collected when you visit our website, IP address and cookies

Our server automatically collects non-personal information from your visit to and browsing through our website(s), and may use cookies to improve your navigation experience. Please notice that all information we gather by the use of cookies is compiled on an aggregate, anonymous basis.

Cookies are units of information installed on your hard drive by the website to support your navigation. In essence, we use cookies to carry information from one session on a website to another, or between sessions on related websites, without having to burden your computer with massive amounts of data storage. Once you register to our website, cookies will also help us to retrieve your personal information to keep you logged in everytime you visit us.

LEA shall never use cookies to gather personal information such as your name, email address or purchasing preferences. We use cookies to determine the path you took to land on our website(s), *i.e.*, whether you were redirected from a third party's website, a banner or a tracking link used by one of our promotion partners. Be aware of that **LEA** may not have access to all cookies or the information therein contained; thus we are not responsible for the actions or policies of such third parties. We may collect information about your computer, including where available your IP address, operating system and browser prototype, for system administration, customer support, promotion campaigns of our own products/services as well as to provide

aggregate information to our marketing associates. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

You can erase cookies from your hard drive system, block them or receive a warning before they are stored, directly on your browsers menu. Information you provide us
